Biography

Her work included drafting statutory and regulatory language aimed at creating efficient and effective governance frameworks.

Before her time at OMMA, Kristin was an attorney at Legal Aid Services of Oklahoma, where she represented hundreds of indigent survivors of domestic abuse. She also developed and led an eviction defense clinic during the COVID-19 pandemic, helping to keep vulnerable Oklahomans housed.
