Will's experience includes representing employers in discrimination and retaliation claims involving the Americans with Disabilities Act (ADA), Age Discrimination in Employment Act (ADEA), Fair Labor Standards Act (FLSA), Family and Medical Leave Act (FMLA), Pregnancy Discrimination Act (PDA), Title VII, 42 U.S.C. §§ 1981 and 1983 claims, and whistleblower claims.

Will and HBS Partner Charles A. Dorminy, in an issue of first impression in the Eleventh Circuit, successfully argued that the FMLA does not provide standing for a plaintiff to allege an "associational" or third-party retaliation claim against an employer for the protected acts of a third party. In addition, Will has successfully obtained summary judgment for an employer, a local Sheriff's Office, in a case involving alleged discrimination and retaliation under the FMLA and PDA.

Will has also authored employment handbooks for local health care providers.

## Medical Malpractice

Will represents the interests of hospitals, health systems, skilled nursing facilities, physicians, surgeons, dentists, nurses, and other medical professionals from pre-suit claims and investigation through trial and appeal.

He has experience in representing medical professionals in all types of professional negligence cases, including catastrophic birth trauma cases. Will has a breadth of experience with the expert affidavit requirements, expert qualifications requirements, and Daubert requirements in Georgia and has successfully argued and obtained dismissals of actions for a party's failure to comply with such requirements.
