## **Location**

up at night and can be seen from miles away. The Atlanta office's entrance is on the 29th floor, and directions for accessing along with important information to keep in mind once you arrive are below.

## Transit Options

- Driving & Parking: There are paid parking garages accessible from Peachtree Center Ave NE you can access.
- Rideshare: Select the Peachtree Center Avenue NE entrance as your drop-off point.
- Metro: Take MARTA to the [Peachtree Center Station](#). Exit on Peachtree Street (North) & Ellis Street NE (East), then walk north along Peachtree Street to the West Entrance of the building.

## Entering the Building

There are two entrances into the building, and building staff are located throughout that can assist you.

- From Parking Garage: Once parked, locate the elevators and take them up to the Lobby Level, then take elevators again to Level 29.
- West Entrance & Main Lobby: Located off Peachtree Street, this is the primary entrance to the building. Once inside, walk straight down the main hallway, continue along the right side, and take the elevators up to floor 29.
- East Entrance & Lower Lobby: Located off Peachtree Center Avenue NE, this is the secondary entrance and likely rideshare drop-off, as there is a vehicle turnaround. Once inside, take the elevators or escalator up, then from the main hallway take the elevators in the middle up to floor 29.
